Considerations:

- There are several rooms allowing to seat between 6 and 4 people, but only one room can be assigned per company.
- Sessions will last 4 hours. Morning sessions start at 10:00 am and end at 2:00 pm; while
 afternoon sessions are from 4:00 pm to 8:00 pm. On Fridays, only morning sessions will be
 scheduled.
- Depending on availability, several visits may be scheduled. However, only a maximum of 4 consecutive sessions, or two complete days, may be requested within the same week. A maximum of 12 sessions per company per process may be requested.
- Visit requests shall be made at least 3 days in advance.

- On the day of the visit, authorized attendees must show their official ID at the Data Repository (for Mexican citizens: Voting Card, Professional License or Passport; for Foreigners: Passport or Residence Card issued by the National Institute of Migration).
- An additional ID must be brought for entry registration (driver's license, company ID, etc.)
- Access to the Data Repository with electronic, storage or communication devices, such as computers, cellphones, flash drives, among others, will not be granted. These objects may be stored in lockers with key, located in the Data Repository reception.
